Only those materials are accepted for consideration that have not been previously published, and are prepared in accordance with the requirements.

Abstracts of the scientific report:

- up to four pages,
- annotation 250 characters,
- keywords 5-8 words,
- without a list of references.

Materials that do not meet the requirements, will not be accepted for consideration. Only those materials are accepted that fully correspond to the conference theme, have scientific and applied significance. Papers submitted after the final term will not be considered by the Organizing Committee. The Organizing Committee reserves the right to make the final selection of papers for the conference in accordance with the announced topics and according to quality criteria.

The authors are obliged to adhere to the principles of academic integrity, including in terms of ensuring the scientific level of the text of the reports, the validity of the conclusions, and the reliability of the results. The authors are responsible for the content of the abstracts.

In case of rejection of the submitted materials, the author will be notified by the Scientific Secretary of the conference via email within 10 working days from the date of registration. Materials are not reviewed and are not returned.

Materials are not subject to additional editing, so they should be carefully prepared.

Requirements for abstracts

1. The volume of abstracts - up to 4 pages of A4 format (297x210 mm); orientation - portrait; text editor - Microsoft Word, version not older than 6.0; all borders - 20 mm; font (typeface) - Times New Roman; size - 14; line spacing - 1,5; style - Normal; pages - without numbering; do not use forced hyphenation and extra spaces.

2. Structure of the abstract and formatting parameters of its main components:
